Clients have 30 (thirty) days to deposit on a booking from the date the first quote is delivered. Bookings made after 30-day mark will require payment of a new Trip Development Fee.

I accept that Indo Bleu Travel is NOT responsible for, nor will I attempt to hold it liable for any injury, damage or loss I suffer for any conditions, actions or omissions that are beyond the reasonable control of Indo Bleu Travel.

I understand that if traveling internationally I, and all persons traveling with me, must have a valid passport and, depending on my destination and the origin of my passport, our guests and I may need to obtain a visa. Proof of citizenship is required for travel outside the United States. Indo Bleu Travel will advise me of the supplier's refund, change and cancellation fees and penalties. I am aware that the airline ticket, especially holiday, group and discounted fares, may be subject to the loss of some or all of the fare or require the expenditure of additional money if I elect to change or cancel this reservation.

I will review and agree to all the terms and conditions of penalties on resorts, tours/excursions, insurance and airlines. I will review the travel documents upon receipt for accuracy. I understand that I may contact Indo Bleu Travel if I have questions at any time.

I agree with the above terms and conditions and appoint **Samantha Ritchie** of Indo Bleu Travel to research my vacation plans. I understand this fee to be nonrefundable as remuneration for her professional efforts made on my behalf. Cancellation Fees

Indo Bleu Travel charges Cancellation Fees based on the following schedule:

0-60 days of the initial deposit payment date: \$50 + the supplier's fee, if applicable.

61-90 days of the initial deposit payment date: \$100 + the supplier's fee, if applicable.

91 or more days after the initial deposit payment date: \$150 + the supplier's fee, if applicable.
